#### **Event Requirements**

- · Conduct match in accordance with SASS Rules, and within the outline of the guidelines provided.
- Offer a minimum of 10 Main Match Stages and Side Matches
- Event must take place over a minimum of 2 days.
- Hold a SASS Costume Contest utilizing the SASS Costume Contest Management and Administration Handbook.
- Hold a SASS Scholarship Foundation or SASS Museum Fundraiser of the Club's choosing.
- The highest overall placed male and female whose primary US residence is located within the state will be recognized as the SASS State Champions.
  - The determination of primary residence may be established by any one of the following means: A valid US Driver's License or state issued ID.
- All Entrants must be active SASS Members.

#### **Terms & Cancellation Policy**

This contract is valid for one calendar year. If your event must be canceled, please notify SASS immediately. A cancellation fee of \$200.00 applies to any sanctioned event canceled less than **90 days** prior to the event's start date.

#### **Club's Commitment to SASS**

- Club must be a SASS Affiliated Club and have met the affiliation insurance requirements.
- Provide single card recognition as "SASS Presents" before "MATCH TITLE" and "THE SASS (Location) COWBOY ACTION SHOOTING CHAMPIONSHIP" after "MATCH TITLE" in all advertising, printed materials, event program cover, shooters program and awards presentations.
- Print the "SASS SANCTIONED MARSHAL" logo in every instance the "MATCH TITLE" is used as outlined in the previous paragraph.
- Provide display space for SASS banners.
- Two match entries with full access to event activities for any SASS representatives in attendance.
- 10' x 10' SASS vendor display space if SASS representatives are in attendance.
- Sanctioning fees of \$5.00 per paid shooter, along with the official submission form must be sent to SASS within 30 days of the conclusion of your event. The sanctioning agreement carries a \$100.00 minimum sanctioning fee regardless of the number of paid shooters.
- A full shooters list must be sent to SASS for Active Membership Verification at least 30 days prior to the match and a final list is to be sent once the match registration has closed.

#### SASS commits to fulfill its match sanctioning support by providing the following:

- Endorsement of the match as a SASS Sanctioned Championship.
- Championship awards for Overall Man & Lady. \*Black Powder Matches receive pins only.\*
- \$200 in SASS Mercantile Gift Certificates.
- Space for a post-event article in The Cowboy Chronicle. (Article preparation and submittal is the responsibility of the host club.)
- Championship select exposure on the SASS Website and a listing in The Cowboy Chronicle.
