Thank you for your club's interest in hosting the SASS Cowboy Action Shooting Championship Program.

Please take the time to read and understand the information and expectations as outlined for sanctioning your match. By signing and submitting the application, you attest to your understanding, commitment, and agreement to the terms outlined. This signed application, upon approval by SASS, becomes your sanctioning contract.

The Single Action Shooting Society® (SASS) is the governing and sanctioning body for the sport of Cowboy Action Shooting™ and Wild Bunch Action Shooting™ Worldwide.

Sanctioning Fees

SASS Annual matches pay a \$5.00 per paid shooter sanctioning fee. The sanctioning agreement carries a \$100.00 minimum sanctioning fee regardless of the number of paid shooters. You are required to submit the appropriate sanctioning fee, along with the official submission form, within 30 days of the conclusion of your event.

Cancellation Policy

If your event must be cancelled, please notify SASS immediately. A cancellation fee of \$200.00 applies to any sanctioned event cancelled less than 90 days prior to the event's start date.

SASS commits to fulfill its match sanctioning support by providing the following:

- Endorsement of the match as a SASS Sanctioned Championship.
- Championship awards for Overall Man & Lady Winners.
- \$200 in SASS Mercantile Gift Certificates.
- Space for a post-event article in *The Cowboy Chronicle*. (Article preparation and submittal is the responsibility of the host club.)
- Championship select exposure on the SASS Web.

Site and a listing in *The Cowboy Chronicle*.

- *Black Powder Matches receive pins only.

Club Agrees to the Following:

- Conduct match in accordance with SASS Rules, and within the outline of the guidelines provided.
- Provide single card recognition as "SASS® Presents" before "MATCH TITLE" and "THE SASS (Location) COWBOY ACTION SHOOTING CHAMPIONSHIP" after "MATCH TITLE" in all advertising, printed materials, event program cover, shooters program, and awards presentations.
- Print the "SASS SANCTIONED MARSHAL" logo in every instance the "MATCH TITLE" is used as outlined in the previous paragraph.
- Provide display space for SASS banners.
- Event Program advertising: One black and white full page on inside front cover, dedicated to SASS.
- 10' x 10' SASS vendor display space.
- Two passes to the event, Hospitality Tent, and all social functions.
- Submit appropriate sanctioning fees to SASS within 30 days of completion of your event. (\$5.00 per paid shooter, with a \$100 minimum sanctioning fee.
